This fee for basic services and overhead includes, but not limited to, consultation with the family, clergy and other outside sources pertinent to funeral services, housing other remains, gathering authorizations for death certificates ,burial permits, coordinating with cemetery, crematory or other cash advance third party services/merchandise and follow-up visits. This is a non-declinable fee.

EMBALMING \$495.00

Embalming is the process of disinfecting, sanitizing and preserving of dead human remains. **Except in certain special cases**, the law does not require embalming, however if you select certain funeral arrangements, such as a funeral with viewing, embalming is required. If you do not want embalming, you usually have the right to choose an arrangement that does not require it such as, direct cremation or immediate burial.

TRANSPORTION & AUTOMOTIVE EQUIPMENT

All rates are for local service within a 30-mile radius. There will be additional charges for outside the local service radius, \$3.00 each mile. All limousines and lead cars are limited to 4 hours usage. There is an additional \$100.00 hourly charge for usage beyond the 4 hour limit. There will be a 40% increase on all limousines and cars for Saturday, Sunday and Holiday services.

Transfer of remains to the Funeral Home (first Call Service) **\$490.00**

Fees include services within a 30-mile radius of the funeral home. Any additional miles will be charged \$3.00 per mile.

SERVICES

DIRECT CREMATION **\$1,395.00**

If you Choose to arrange a direct cremation, you must use an alternative container or a combustible casket. Alternative containers encase the body and can be made up of composition materials, (with or without an outside covering). We offer some caskets which are cloth-covered and/or unfinished wood boxes.

Our charge includes: basic professional services of Funeral Director and Staff, 1st call pick up, embalming, dressing and casketing, and transportation to a local cemetery (within a 30-mile radius). There will be an additional charge, if authorized, for embalming, dressing and casketing with a maximum of (2) days refrigeration and use of Funeral Director and Staff for a Memorial Service if applicable. These packages do not include any other merchandise or services and any applicable sales tax will be added.
