**EMBALMING \$495.00**

Embalming is the process of disinfecting, sanitizing and preserving human remains. **Except in certain special cases,** the law does not require embalming, however if you select certain funeral arrangements, such as a funeral with viewing, embalming is required. If you do not want embalming, you usually have the right to choose an arrangement that does not require it such as, direct cremation or immediate burial.

### **DIRECT CREMATION** **\$1,695.00**

If you choose to arrange a direct cremation, you must use an alternative container or a combustible casket. Alternative containers encase the body and can be made up of composition materials, ( with or without an outside covering). We offer some caskets which are cloth-covered and/or unfinished wood boxes. **INCLUDES FREE PLASTIC URN CONTAINER.**

Our charge includes: basic professional services of Funeral Director and Staff, 1st call pick up, (within a 30-mile radius) and cremation. **There will be an additional charge, if authorized, for embalming, dressing and casketing with a maximum of (2) days refrigeration and use of Funeral Director and Staff for a Memorial Service if applicable. These packages do not include any other merchandise or services and any applicable sales tax will be added.**

- A. Overweight Cremation fee exceeding 300lbs **\$260.00**
- B. Overweight Cremation fee exceeding 400lbs **\$310.00**

**RECEIVING OF REMAINS (From Another Funeral Home) \$1,695.00**

Our charge includes: basic professional services of Funeral Director and Staff, A proportionate share of our overhead costs, care of remains, transportation of remains to funeral home and to cemetery/crematory. **There will be an additional charge of \$4.00 per mile for traveling outside the local service radius of 30-miles. (This fee does not include merchandise, formal viewing of remains, funeral ceremony, airfare, cremation fee, casket destruction or applicable sales tax).**
